3	2/6/25	Can specialized years of experience be used in lieu of standardized licensing?	Regarding licensing, the Proposer shall have a State of Alaska business license at the time of proposal.	
4	2/6/25	Can we hire an engineering advisor representative per the OSHA requirements to satisfy the engineering staff requirement instead?	It is unclear which OSHA requirements are being referenced with regards to the engineering staff qualifications required of the Proposer. Please clarify.	
5	2/6/25	Is programming on any level to be included as part of our bid or not? Clarification to which items if so.	The RFP lists BMA Software Solutions as the Remote Control Systems programmer for this Project. The Proposer is expected to include BMA and indicate their cost as well as any coordination labor costs in the proposal submittal. The Proposer shall be responsible for providing additional programming services, which shall include but not limited to DSP, networking hardware configuration, lighting system integration. Further, the Proposer shall be responsible for the coordination of manufacturer provided commissioning. The Proposer shall account for additional limited programming to accommodate end-user requested adjustments, as described in the Specifications.	
6	2/6/25	What happens if a piece of OFCI equipment tests bad during the Contractor Testing Period?	It is expected that in the event that any Owner furnished equipment is proven faulty or non-functioning, an RFI will be submitted to the Owner and Consultant so that a recommended course of action can be devised. Refer to the Project Change Order process described in 1.5.F of the Specification.	
7	2/6/25	What happens if equipment vendors are out of stock and cannot meet the proposed timeline?	As part of Proposal, it is requested that the Proposer submit a list of long lead time items to be identified for early release for procurement.	
8	2/6/25	In Section 2.3.F.2.A, Is FR Venue Distro9 HDR supposed to be RF Venue Distro9 HDR?	The intended device (ANTD) is to be the RF Venue Distro9 HDR.	
9	2/6/25	In Section 2.4.Y.1.A, Is the AJA KI PRO Ultra supposed to be AJA KI PRO Ultra 12G?	Section 2.4.Y (ISO2) refers to accessories for the OFCI device identified in Section 2.1.A.2.p which is the AJA KI Pro Ultra. Proposer to furnish (2) AJA PAK 1000 media drives per OFCI unit that is to be reintegrated as indicated in the design documentation. Replace existing drives and return to owner.
